Approval of Summer School Courses

Mrs. Kersting Rudd made a motion to approve the Summer School Courses as presented. Mrs. Brewer seconded the motion; motion carried 5-0

First Reading of Corporation Plans

Dr. Zupin discussed The First Reading of Corporation Plans. The first plans discussed were Strategic and Accountability Plans. Goal 1: To provide a diverse and relevant curriculum for all students. Goal 2: Continuous growth of student academic achievement. Goal 3: Healthy financial stability and Goal 4: Engage community, parents, and business leaders. A summary of changes are to address learning loss and skill gaps due to COVID-19 closure and concentrate on creating and maintaining a healthy balance of cash reserves and appropriate student/staff expenditures. The second plans were Technology Plans. Goal 1: Teaching and learning. NJ-SP students will learn to use and care for their devices. NJ-SP teachers and students will exhibit knowledge and skills utilizing software, programs, and assessments. Goal 2: Professional Development for Teachers. NJ-SP teachers will demonstrate competency in creating and delivering quality instruction using technology devices. Goal 3: Device/Hardware Goals. NJ-SP will send devices home with students at the beginning of the 2021-2022 school year. Goals 4 and 5: Infrastructure and Financial Goals. A summary of changes are that devices will go home with students next school year. Determination of which grade levels, repair processes will be established, repair funding will be created, and teaching and learning strategies utilizing more technology. The third plans discussed were Wellness Plans. Goal 1: Nutrition Education. Goal 2: Nutrition Promotion. Goal 3. Physical Activity. Goal 4: Other school-based activities. Goal 5: Implementation of Evaluation. A summary of changes are to update and change activities offered to our students are afterschool activities and extra-curricular offerings. The fourth plans discussed were Bullying Prevention and Intervention Plans. Goals discussed were Definitions, State Laws/Statutes, Resources, and Processes/Procedures (must report: Anonymous, Administrator or Teacher). A summary of changes are to keep current with state statutes and explore possible use of an App to report issues.

Legislation Update

Dr. Zupin explained HB 1005/SB 413; an aim to expand school choice options for families, increase income eligibility for school choice vouchers, and create a new funding program for some students not enrolled in public schools to receive state tuition support dollars. Harmful effects discussed from these Bills include diverting taxpayer funds from public schools to private schools and reducing fiscal and academic accountability (some private/charter schools accountability is less stringent) and the original "theory" or "goal" of advocating for poor students and minority students from failing, urban public schools have been lost. With increased income eligibility being in the \$70,000 range to \$140,000 range. Is this really helping who it was originally intended to help? In summary, put public funds to public schools so we can fully deliver the services and programs that our students need.

ESSR CARES 2.0

Dr. Zupin discussed the ESSR CARES 2.0 would add additional dollars to schools, it will address air quality and loss of learning. NJ-SP will look at hiring additional staff in the next couple of years to address learning loss, social-emotional health needs, and smaller classroom sizes. NJ-SP will look at ways to improve airquality and use these funds to do so. Funds need to be spent in 2 years (by Fall of 2023).

Elementary School Project Update

Dr. Zupin updated that the week of March 29 fiber optic work will begin, the week of April 5 securing the site (playground area) and ground breaking for the new gym will begin. April and May work on the Elementary Gym will take place and June 1 will begin work on the West Wing of the school, main office, and continued work on the gym. A Bus Garage update was given stating "Poles set, digging foundation, pour footings, floor slab will be done in approximately 2 weeks and FBI comes in after floor slab".

COVID-19 Update

Dr. Zupin updated that vaccine for teachers was conducted onsite and cases are still minimal.

Superintendent's Report

Dr. Zupin reported Spring Break will be March 29-April 2. The students last day will be May 27 due to a makeup day from a snow day in February and the Graduation Ceremony will be June 6 and will take place outdoors due to COVID-19 precautions and gym construction.
