Substitute Teacher Pay

Dr. Zupin discussed substitute teacher pay which is currently \$70 should increase to \$80.00 stating, "Surrounding schools are very similar and even lower."

Fanning and Howey discussed updates on the Elementary project.

Superintendent's Report

Dr. Zupin reported the 2020 ADM is 948.68, down 42.25 from last year. Following the trends of other neighboring schools and small rural schools across the state, she stated, "We anticipated this and already matched our staff with enrollment for this school year. The key is to keep staff and enrollment in line with each other. We have done a great job of that in the past several years."

Other

During Board Comment, Sandra Kersting Rudd inquired about the SEEDS preschool and if they have taken occupancy or not in the Middle School. Dr. Zupin said they had not and explained that there was a delay due to COVID-19. Discussion revolved around as to whether we needed to cancel the lease or continue to wait until SEEDS decides to take occupancy.

It was decided to inform SEEDS Director, Brandy Pohl that she has until January 1, 2021 to take occupancy and begin paying the lease amount. If occupancy is not taken and lease is not paid by that date, the lease agreement will be cancelled. It was also emphasized that a new lease agreement would be considered in the future if SEEDS decided to wait.

A motion was made, seconded and passed.

Mrs. Brewer made a motion to cancel the preschool lease if no progression is made by January 1, 2021 per satisfaction of Dr. Zupin as presented. Mrs. Rudd seconded the motion; motion carried 4-0.
